

Requirements

Valid Identification:

- Driver's license, Military ID or State ID cards issued more than six months ago. Parents getting passports for their children must bring proper documents showing they are the father, mother or legal guardian. (Long form birth certificate, adoption papers, etc).
- If out of state resident, a second form of ID is required.
- If the ID was issued less than six months ago, a second form of ID is necessary.

Social Security Number:

- A Social Security number is required for all passport applications, regardless of the applicant's age.

DS-11 (12-2010) Passport Application

- Applicants must fill out DS-11 Passport Applications available at any passport acceptance facility, passport agency or online at www.travel.state.gov
- **DO NOT SIGN** the DS-11 Application until instructed to do so.

PLEASE NOTE: The Clerk's Office is **NOT** a passport agency. It is an application acceptance facility and cannot issue passports. To check the status of your passport, call 1-877-487-2778; **TDD**

Requirements

Proof of U.S. Citizenship:

- Certified copy of birth certificate - with names (with county or state embossed seal, not hospital certificates). To find out where to obtain a certified copy of your birth certificate, visit <https://www.cdc.gov/nchs/w2w/index.htm> .
or
- Naturalization Certificates
or
- Citizenship Certificates
or
- Previously Issued Passport* (If your name has changed from your previous passport, you must submit a certified copy of the document showing name change, marriage license, divorce decree, etc).
- Social Security cards, Voters Registration cards or Military Discharge papers are **NOT** acceptable proof of your identity.

Photographs:

One Photograph that:

- Measures 2x2 inches.
- Must have been taken within the past six months.
- Must be in color and show current appearance.
- Must be full-faced, front-view with plain white or off-white background.
- Must show between 1 inch and 1 3/8 inches from bottom of your chin to top of your head.
- Must show you in normal street attire (unless religious attire you wear daily).
- No hat or headgear that obscures your hair or hairline.
- If you normally wear prescription glasses, a hearing device, a wig or similar article, these should be worn for your photograph.
- Dark or nonprescription glasses with tinted lenses **NOT** acceptable unless worn for medical reasons.
- The Clerk's Office can take photographs for \$15 at Brandon and Southshore locations **ONLY**.

You will need two separate forms of payment:

- Payment to the U.S. Department of State may be made by **check or money order only**.
- The payment of \$25.00 to the Clerk of the Circuit Court may be made by cash, check, money order, or credit card (Visa, MasterCard, American Express, or Discover—3.5% service fee charged).

Passport Card

The Passport Card is **NOT FOR TRAVEL BY AIR**.

The Passport Card can **ONLY** be used for land and sea travel between the United States, Canada, Mexico, Bermuda and the Caribbean.

SUBMIT A PHOTOCOPY OF THE IDENTIFICATION DOCUMENT PRESENTED

- 1) The photocopy must be of the ID document that you will present when you apply.
- 2) Photocopy must be on plain white “8 1/2 x 11” standard paper.
- 3) The paper should be free of other images and /or markings.

Children (under age 16)

CHILDREN UNDER 16 YEARS OF AGE MUST HAVE BOTH PARENTS PRESENT OR ONE PARENT AND A NOTARIZED CONSENT LETTER OR DS-3053 FORM FROM THE ABSENT PARENT, **ALONG WITH A COPY OF HIS/HER IDENTIFICATION—FRONT AND BACK****

There is an additional \$25 fee for EACH PASSPORT APPLICATION PROCESSED to be made payable to the Clerk of the Circuit Court which must be in a separate form of payment.
