##### **PETITION FOR DELAYED BIRTH CERTIFICATE**

(You want to ask the court to issue a birth certificate because **one has never been issued.**)

(You want to apply for an Amended Birth Certificate as a result of an adoption, legal name change, or a paternity action, **and** you have a certified copy of a final judgment.)

# FAMILY LAW PACKETS

## **CHILD SUPPORT**

### **MODIFICATION OF CHILD SUPPORT**

(You want to ask the court to change the amount of child support that was ordered - NOT to be used to modify an Administrative Support Order.)

### **ANSWER TO SUPPLEMENTAL PETITION TO MODIFY CHILD SUPPORT OR MODIFY PARENTING PLAN/TIME-SHARING SCHEDULE**

(You were served with a Modification of Child Support case and want to file an answer.)

### **CHILD SUPPORT UNCONNECTED WITH DISSOLUTION OF MARRIAGE**

(You want to ask the court to enter a support order if you and your spouse are married but separated, the child(ren) live primarily with you, and a Dissolution of Marriage case has NOT been filed.)

### **BLANK MOTION**

(You want to file a motion in an existing case -- for example: emergency motions, motion for child support credit, motion to reinstate driver license, motion to stop child support.)

**packet #6**

### **MOTION FOR PAYMENT CREDIT**

(You want to ask for a child support or alimony credit and the other party agrees and is willing to sign the form.)

**packet #7**

### **PETITION TO CONTEST DRIVER LICENSE SUSPENSION**

(You have received a notice stating that your driver's license will be suspended.)

### **MOTION TO CONTEST DELINQUENCY**

(You have received a notice stating that a judgment will be filed against you.)

### **MOTION FOR CONTEMPT/ENFORCEMENT**

(The other party is not following what they were ordered to do/not do and you want to ask the court to enforce the order.)

### **PETITION FOR SUPERSEDING CHILD SUPPORT ORDER WITHOUT TIMESHARING**

(You already have an existing Department of Revenue \*ADMINISTRATIVE\* child support order AND a separate order addressing custody, visitation, parental responsibility, and/or timesharing and you want a circuit court support order to supersede the Administrative support order.)

### **PETITION FOR SUPERSEDING CHILD SUPPORT ORDER WITH TIMESHARING**

(You already have an existing Department of Revenue \*ADMINISTRATIVE\* child support order and there is NO order addressing custody, visitation, parental responsibility, and/or timesharing and you want a circuit court support and timesharing order that will supersede the Administrative support order.)

## **DISSOLUTION OF MARRIAGE (DIVORCE)**

### **WITH CHILDREN**

(There are minor or dependent children who were born to the parties or born during the marriage – even if they are not the Husband’s children.)

#### **BOTH PARTIES AGREE**

(Both parties agree on all issues & will complete all necessary forms & requirements.)

#### **PERSONAL SERVICE**

(The other spouse will be served with the case.)

#### **PUBLICATION**

(You cannot locate your spouse or your spouse has never lived in Florida.)

#### **ANSWER**

**packet #18**

(You have been served with a dissolution of marriage case and want to file an answer.)

### **NO CHILDREN**

(There are no minor or dependent children who were born to the parties or born during the marriage – even if they are not the Husband’s children.)

#### **BOTH PARTIES AGREE**

**packet #19**

(Both parties agree on all issues & will complete all necessary forms & requirements.)

#### **PERSONAL SERVICE**

**packet #20**

(The other spouse will be served with the case.)

#### **PUBLICATION**

**packet #21**

(You cannot locate your spouse or your spouse has never lived in Florida.)

#### **ANSWER**

**packet #22**

(You have been served with a dissolution of marriage case and want to file an answer.)

### **SIMPLIFIED**

**packet #27**

(There are were no children to the parties or born during the marriage; both parties agree on all issues; both parties will sign the petition; and both parties MUST be present at the hearing.)

## **MOTIONS**

### **BLANK MOTION**

(You want to file a motion **in an existing case** -- for example: emergency motions, motion for child support credit, motion to reinstate driver license, motion to stop child support, motion for temporary custody.)

(You want to ask for a child support or alimony credit and the other party agrees and is willing to sign the form.)

### **MOTION FOR CONTEMPT/ENFORCEMENT**

(You have legal custody of the child(ren) and you want to ask the court to enter an order directing law enforcement to take a minor child(ren) from the person who currently has physical possession and deliver the child(ren) to you. You must have an existing Hillsborough County case or must file a Petition to begin a case before you can use this motion.)

### **MISC. MOTION**

You want to file a Motion for one of the following:

- to Set Aside Dismissal and Re-Open Case, or
- for Rehearing, or
- to Vacate, or
- to Compel Compliance with Mandatory Disclosure

### **MOTION FOR INJUNCTION TO PREVENT REMOVAL OF CHILDREN**

(You want ask the court to enter an order requiring that the child(ren) not be removed from Florida **while a custody case is pending.**)

(You must have a pending case filed to use this motion. Use this form to file a request for the court to issue a temporary timesharing, support, or other relief order while your case is pending.)

(You want the court to order child support and/or alimony payments to be deducted from the obligor's paychecks)

(Both parents will fill out and file forms.)

#### **PERSONAL SERVICE**

(The other parent will be served with the case.)

#### **PRIVETTE**

(The mother of one or more child(ren) of the parties was married to someone else at the time of conception and/or birth.)

(You have been served with a paternity case and want to file an answer.)

(You want to move more than 50 miles with the child(ren) in this case and there is an existing court order addressing custody, visitation, parental responsibility, and/or timesharing, OR there is a pending case addressing custody, visitation, parental responsibility and/or timesharing.

(You want to ask the court to change the parenting plan/timesharing provisions of a Hillsborough County court order.)
