CLERK STAFF WILL USE THIS EMAIL TO SEND YOU A CONFIRMATION ABOUT THE DOCUMENT YOU SUBMITTED AND INSTRUCTIONS ON WHAT TO YOU MAY STILL NEED TO DO TO FINISH YOUR REQUIREMENTS FOR THIS TICKET. THE TELEPHONE NUMBER FIELD BELOW IS OPTIONAL.

IF YOU WOULD LIKE A COURT DATE TO CHALLENGE THE TICKET YOU CAN DO THAT AS WELL.

Every option will not be available for every ticket depending on the violation and your driving history.

You will get a popup like this. **The Clerk always sets any court date requests for the next available court date. You do not get to choose the court date you want.** You can either accept this court date by clicking on the orange "Schedule Court Date for Selected Date" or you can cancel and do something else.

DO NOT WAIT TOO LONG -- YOU MUST SELECT A COURT DATE WITHIN 30 CALENDAR DAYS FROM THE DATE YOUR TICKET WAS ISSUED.

ONCE YOU'VE SELECTED:

ENTER THE REQUIRED INFORMATION IN THE "PLEASE CONFIRM YOUR PURCHASE" POP-UP BOX.

Selecting "Pay Case Costs \$XXX.XX" will direct you to the My Florida Counties website to process the payment.

Selecting "Continue Shopping" will allow you to pay additional citations and/or court costs.
