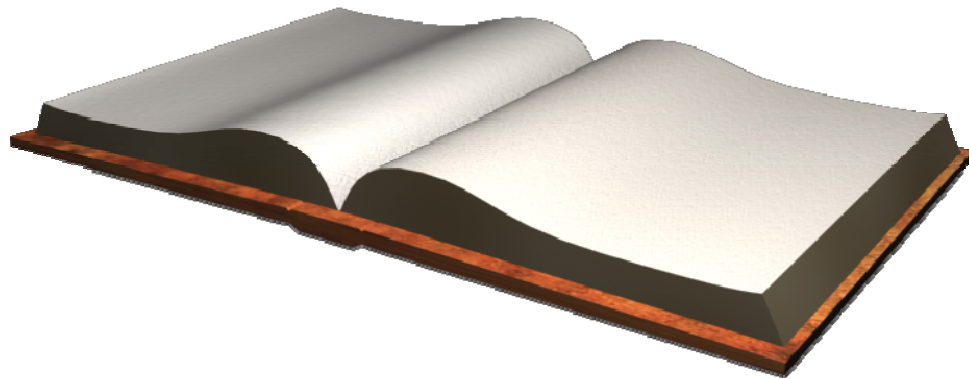

The Payment History is divided into four sections as follows:

**FAMILY LAW CASE HISTORY
TERMS
PAYOFF
PAYMENT HISTORY**

Following is a brief description of each section:

*****FAMILY LAW CASE HISTORY*****

This section contains the information about the case i.e. name of judge assigned to the division, case number, personal information about the parties involved, name(s) and date(s) of birth of the minor child(ren), delinquency tracking information, and account totals for amounts paid, assessed, disbursed, adjustments, etc.

*****TERMS*****

This section details the payments that have been ordered by the court to be paid through the CGD. These payments are detailed horizontally by the type of payment followed by the name of the person who is to receive that payment, the frequency in which payment is to be paid, the date that payment is to start and end, the amount, the date the next payment will come due, the status, and the balance due for that payment.

*****PAYOFF*****

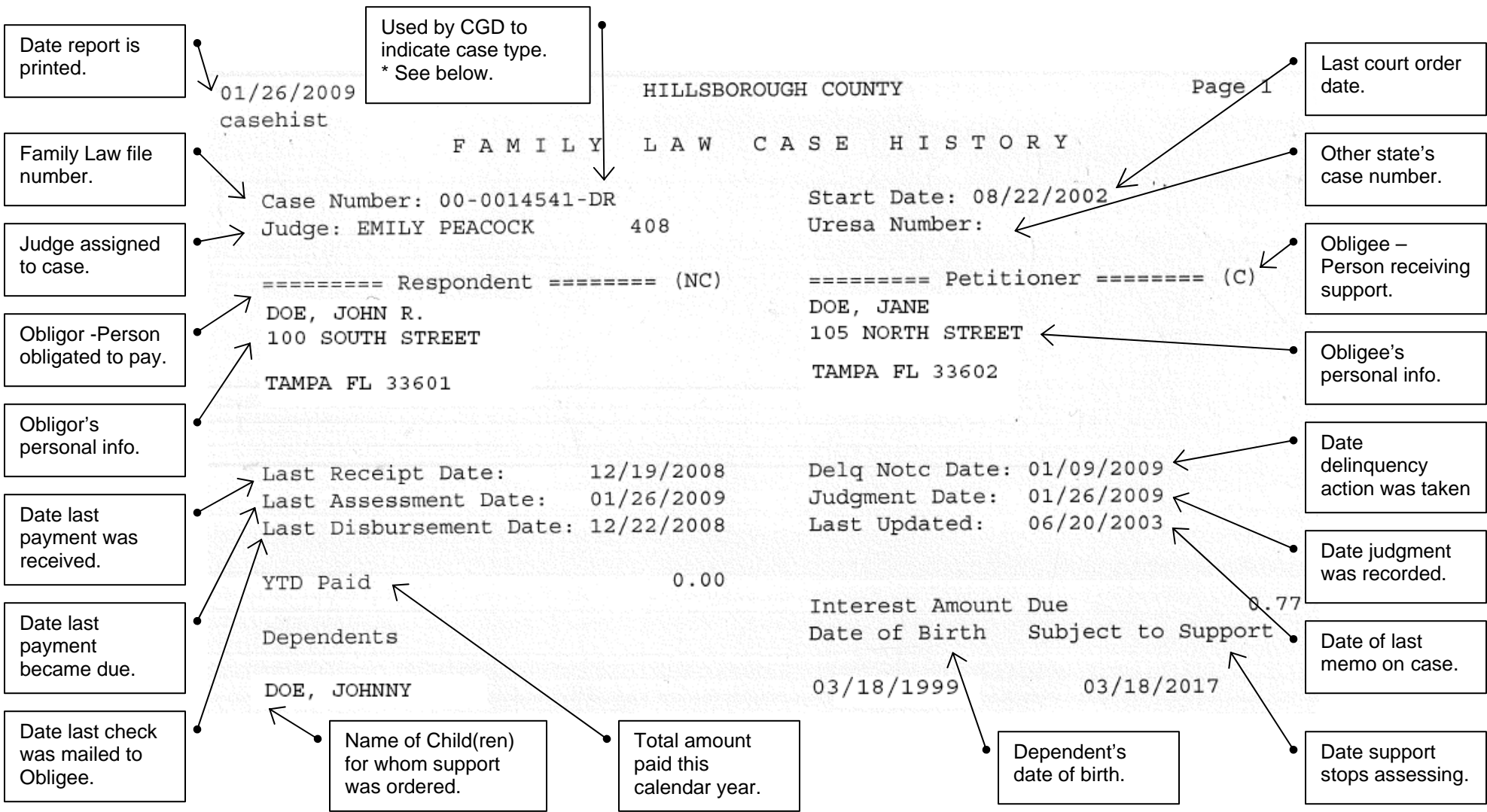
This section provides information concerning the payment of a specified (finite) amount (i.e. specified arrearage, rehabilitative alimony) that is to be paid over a period of time with payments. This section details the type, person to whom amount is owed, the maximum or original amount, the date that payments are to start and end, the amount paid to date toward the original amount, and the payoff amount. The terms of the payback will be detailed in the "TERMS" section.

*****TRANSACTION HISTORY*****

This section provides information on payments and assessments. The payments and assessments are detailed horizontally with the date, the receipt number (if applicable), the type of payment, the person to whom payment is owed, the amount, the check number (if applicable), and the running current due balance.

You can order a Payment History by mail or in person. To order in person please go to the Family Law Department, 800 East Twiggs Street, Room 101, Tampa, FL 33602. To order by mail, send a check or money order made payable to **Clerk of Circuit Court**. Mail to Clerk of Circuit Court, Attn: Child Support, P.O. Box 3450, Tampa, FL 33601. Payment Histories cost \$2.00 per year requested. There is an additional \$2.00 charge to have the Payment History certified.

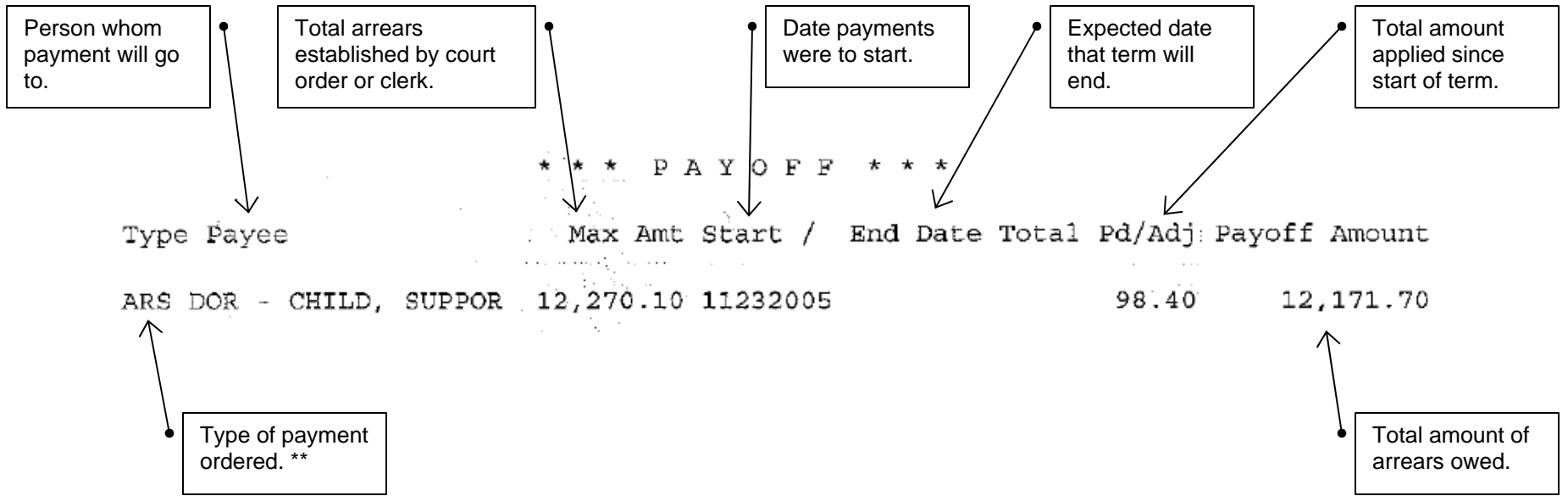

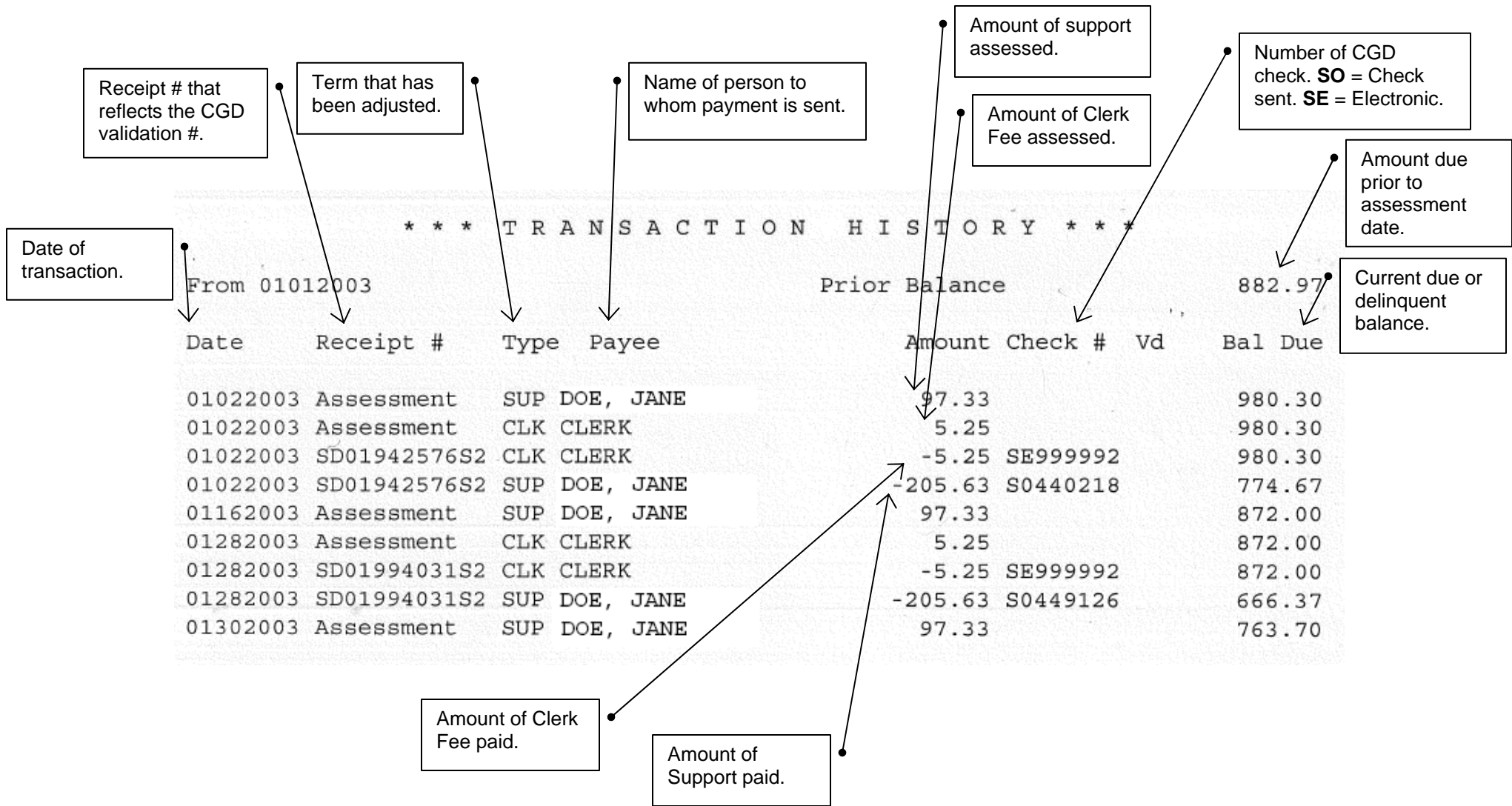
